Dr. Young briefly reviewed the 2020 faculty fellowship report submitted by MCC's Speech & Communications Instructor Leslie Neal.

Dr. Young gave a 2021-24 Strategic Plan update.

Upon motion duly made by Deuling-Ravell and supported by Peterson, the following resolution was unanimously approved:

**BE IT RESOLVED**, MCC's credit hour is increased by \$1 for the purchase of Portfolium: in-district tuition at \$114 per credit hour, out-of-district tuition at \$215 per credit hour, out-of-state tuition at \$351 per credit hour, in-district nursing tuition at \$149, out-of-district nursing tuition at \$250 and out-of-state nursing tuition at \$386, effective with the spring 2021 semester.

The Trustees discussed the earlier joint boards meeting.

Upon motion duly made by Kitchenmaster and supported by Combs, the following resolution was unanimously approved:

**BE IT RESOLVED**, That MCC Part-Time Instructional Services Assistant Sue Moss is the 2020 recipient of MCC's Alden Perkins Dedicated Service Award.

The Trustees briefly discussed the 2021 MCC Stanley & Blanche Ash Distinguished Service Award.
