The Trustees reviewed financial reports.

Upon motion duly made by Combs and supported by Kitchenmaster, the following resolution was unanimously approved:

BE IT RESOLVED, That effective January 12, 2022, an employee hired on or after January 12, 2022, may elect to participate in the Montcalm Community College Optional Retirement Plan by filing an election form within 90 days after the date on which the employee qualifies as an eligible employee. If an eligible employee does not elect to participate in the Plan, the employee will become a member in MPSERS; and That the President and other officers of the college are hereby authorized to sign plan amendments and other documents as necessary or appropriate to amend the plan.

The Trustees discussed the Michigan Community College Association Spring Board meeting that will be held at MCC on March 24 and 25.

At 6:39 p.m., Kitchenmaster moved that the meeting adjourn. Combs supported the motion, which carried unanimously.
