The Trustees reviewed the minutes from their 10/11/22 meeting. Hearing no comments or corrections, Mrs. Carbonelli said the minutes will be accepted as printed.

The Trustees reviewed financial reports.

Mr. Bishop read a letter written by MCC faculty members regarding the 11/2/22 *Daily News* article on the Higher Learning Commission four-year assurance review report.

Ms. Stewart added a bank institution change resolution under New Business and Mr. Marston added a 2022 ACCT Leadership Congress report to the end of the agenda.

Mr. Doezema gave an audit report. He reviewed data from the Single Audit Act Compliance report for year ended 6/30/22 and the Financial Statements and Supplementary Information report for years ended 6/30/22 and 2021.

Upon motion duly made by Marston and supported by Peterson, the following resolution was unanimously approved:

BE IT RESOLVED, That new accounts at Isabella Bank will be created for the purpose of maintaining transactions related to accounts payable, credit card receipts and the Plant Fund. The signatories as described above will be utilized for the new bank accounts.

Upon motion duly made by Combs and supported by Deuling-Ravell, the following resolution was unanimously approved:

BE IT RESOLVED, That Board policy, Section II: Governance Process Policies "Recognition of Distinguished Services" - Emeritus Status: be amended to be "The title emeritus will be granted by the board to each member upon leaving the board if the member has served as least one full six-year term. Privileges include: I. Formal recognition at the Distinguished Service Award ceremony and an award that confers emeritus status. 2. Written invitation, reserved seating, and acknowledgement at the annual commencement ceremony. 3. Invitation to appropriate staff gatherings. 4. Inclusion on appropriate mailing lists."

Upon motion duly made by Peterson and supported by Stump, the following resolution was unanimously approved:

BE IT RESOLVED, That the Montcalm Community College Board of Trustees, gives authorization to the Vice President of Administrative Services, Connie Stewart, to sign any and all documents necessary to revise, with the Internal Revenue Service, the business name of the college associated with the existing assigned EIN number, 38-1790920. This resolution authorizes the elimination of the word District from the name of the college and to reflect the colleges revised name, as Montcalm Community College.
